#### What's In A Name?

The issue of a name change for Methodist College keeps popping up, sometimes from unexpected quarters. Last summer Fayetteville resident Jack Darden wrote in a letter to the editor of the *Fayetteville Observer-Times*, "The school name lacks color, lacks *Je ne sais quoi*, lacks something to give it identity."

Among the suggestions tossed out by Mr. Darden were: "Cape Fear Methodist, Cumberland Methodist, Carolina Methodist, Piedmont Methodist and Fayetteville Methodist."

Other possibilities which have been mentioned on campus include North Carolina Methodist University or Eastern Methodist University. Of course, these names would require that we offer graduate programs, since a university, by definition, grants both undergraduate and graduate degrees. Don't laugh. The name issue, including the meaning of "university", was discussed at one of the first board of visitors meetings back in 1989!

Because some of our current professional programs already require more than eight semesters of academic work, it could be argued that we are moving in that direction. Many in Cumberland County would like to see us offer master's degrees in business and education. While we currently lack the facilities and dollars needed to make such a leap, who knows what the future will bring?

For now, Cumberland residents can pursue graduate degrees at Fayetteville State University, Campbell University, and Pembroke State University and a handful of other schools which have extension programs at Fort Bragg. But Cumberland County is now home to more than 290,000 persons; there's a good market here. Why else would other schools, most recently East Carolina University, offer graduate courses here?

Getting back to the name change, what's wrong with Methodist College? It's too generic and suggests that this is a school for Methodists only. It's outdated. The Methodist Church became The *United* Methodist Church in 1968.

When Methodist alumni and admissions officers mention their Methodist College connections, they're frequently asked, "Which one?" or "Where's that?" Students who were here in the 60's may recall that when the Athletic Department phoned in basketball scores to area TV stations and daily newspapers in other areas, they used the name "N. C. Methodist."

Colleges change their names for a variety of reasons. Atlantic Christian College changed theirs to Barton College several years ago. St. Andrews Presbyterian College in Laurinburg has dropped the word "Presbyterian" from its logo!

Don't look for Methodist to downplay its church affiliation; North Carolina Methodists have invested millions in this institution over the last 38 years. The Public Relations and Admissions offices consider our church-relatedness a clear advantage for marketing purposes.

But the world is changing, and there is keen competition among institutions of higher learning for students, especially in North Carolina. North Carolina used to have 58 "technical institutes"; now we have 58 "community colleges" and 16 state-supported "universities" considered part of the University of North Carolina system.

Names are particularly important for the state's 37 private or independent colleges; we cost more and we must prove that we're worth it. A name with some distinction helps in this regard.

Many private colleges have been forced by changing market conditions to alter their status and mission; others have simply decided they want to step up a notch by offering graduate and professional training. Last year, High Point College (a United Methodist institution) became High Point University. Chowan and Mount Olive, former junior colleges, are now senior colleges.

The nomenclature for United Methodist schools is interesting. Spartanburg Methodist College is a junior college in Spartanburg, S.C. There is a Central Methodist College in Fayette, Missouri. Alaska Pacific University used to be known as Alaska Methodist University. Then there's Southern Methodist University in Dallas. There's infinite variety, but "Methodist College" pales in comparison with the rest. This moniker is simply too plain and limited to do us justice.

Methodist College was chartered in 1956 as a *four-year* coeducational college of liberal arts and sciences. In 1978, the college began offering associate or two-year degree completion programs to capture military students. *It changed out of neces-sity*. Today the college offers bachelor's degrees in 43 fields of study. In the 21st century, a bachelor's degree—four semesters of liberal arts core courses and four semesters of advanced courses in a particular subject—may not be sufficient to ensure access to a good job and the quality of life that most people want.

Times have changed. Perhaps it's time for Methodist College to consider a name change and a limited foray into graduate and professional education. We are losing our values as a Judeo-Christian society. Money has become the new God. Church-related institutions of higher learning must fight to preserve the best of the liberal arts tradition for undergraduates and graduate and professional training which has an ethical component.

# Lura Tally Center Will Offer Special Leadership Training

Methodist College has established the Lura S. Tally Center for Leadership Development, honoring the Favetteville legislator who recently retired after 22 years' service in the North Carolina General Assembly.

Dr. Elton Hendricks, college president, announced at a January 17 luncheon that the center will develop student leadership potential through a three or four-year interdisciplinary program of course work, campus and community service, and off-campus internships. Participants will earn 21 semester hours of credit and an academic minor in leadership.

Dr. Hendricks said the Lura Tally Center will help perpetuate the spirit of strong leadership given to the Fayetteville community and to the state by Mrs. Tally, a former public school teacher and counselor who served five terms in the N. C. House of Representatives and six terms in the N. C. Senate. A graduate of Duke University and N. C. State University, Mrs. Tally authored important legislation in the fields of environmental protection, juvenile detention, day care, and public education. Methodist College awarded her an honorary Doctor of Humanities degree in May 1989.

Twenty-five students—freshmen and sophomores-will enter Methodist's leadership development program this fall and 30 more will be added each year until enrollment reaches 120. Dr. Suzan K. Cheek, associate professor of political science, will serve as program coordinator and recruit students for the program. The Tally Center will also bring a leadership expert to campus for two days each semester to conduct special workshops.

Dr. Cheek and a group of faculty and administrators spent the past two years developing the concept. The Methodist College Board of Trustees approved the program in October 1994. Students selected for the program will take three core courses in leadership, two practicums (one on campus, one in the local community), three electives from a list of existing courses, and complete a senior internship with a government agency, nonprofit organization, or business.

"This is an opportunity for students to

formally synthesize the leadership skills that the Methodist College experience makes available for them," said Dr. Cheek. "Sen. Tally is the epitome of responsible public service and selfless leadership. We are grateful for the opportunity to honor her with this program and are confident that participants will become prominent contributors to their respective communities, including Fayetteville and Cumberland County."

Mrs. Tally said she is "very honored" that Methodist's Center for Leadership Development will bear her name.

She also offered the following thoughts: "I'm particularly interested that young people understand that leadership comes from a great deal of education, a knowledge of what has gone on in the past, and an ability to express concerns for what will be needed in the future. I think it's important for students to get an early understanding of government, to learn how to debate issues, and to help others understand what is at risk during times of change."

# College Will Train Physician Assistants

Methodist College will add a physician assistant program to its curriculum this fall.

Mr. Ron Foster, a physician assistant currently employed by Methodist College, will be the program director. Dr. Christopher Aul, of the Hope Mills Family Medicine Center, will be the medical director. An assistant director will be hired in the near future; adjunct medical faculty will be added later.

The faculty approved the program last May, following a feasibility study authorized by the Methodist College Board of Trustees in February. In addition, the trustees' Building and Grounds Committee has authorized the design of a 13,000 square foot allied health building and family medicine clinic to be built on the campus. The building will be located just south of the main entrance to the college and will face Ramsey Street.

"This is an important undertaking for Methodist College and for southeastern North Carolina." said Dr. Elton Hendricks, college president. "We are grateful for the strong support from the local medical community. Our program will place special emphasis on the recruitment of minority students and students currently residing in medically under served areas who are willing to return to those areas after graduation."

The new program includes a 78semester hour pre-professional phase (two or three years) and a professional phase (two years) in which students receive basic medical education and do clinical rotations. Admission requirements will be rigorous.

Methodist will launch the professional phase of the program in June 1996. Students admitted to the professional phase—either current Methodist

College students or transfers—must have completed the 12 prerequisite science courses plus the core requirements for the Bachelor of Science degree and be otherwise qualified. As currently envisioned, the program will be able to accommodate 30-40 students.

# CHECHEN SAYS Russian Invasion WILL FALL SHORT

The Russian invasion of Chechnya, a former Soviet republic in the Caucasus Mountains, has been very difficult for one Methodist College student.

Said-Ammi Chamilov, 22, is from a village just south of Grozny, the Chechen capital. On January 9, he was jolted by the front page of U.S.A. Today, which carried a photo of his brother and several other Chechens atop a captured Russian tank. His brother is a dentist,

but took up arms after the Russian army invaded Chechnya in mid-December.

Ammi or Emil, as he now likes to be called, came to America last August in search of a college where he could study econom-

ics. He holds a degree in English from a college in Grozny and formerly worked as an interpreter/translator for the Chechen government.

With the help of U.S. missionaries abroad and an acquaintance who now lives in Charlotte, he was able to find a host family-David and Diane Chatellier of Spring Lake. Nancy Alexander, an English instructor at Methodist who knows the Chatelliers, was introduced to him and suggested that he enroll at Methodist.

Jane Cherry, adviser to Methodist's international students, helped Chamilov through the admissions and certification process. His family and a Chechen relief organization are helping him financially.

Emil is the second youngest of six children. His father, a construction engineer, died when he was three. His mother supported the family by working as a janitor and by selling clothing.

When the Russians invaded Chechnya December 11, Emil was just beginning his exams. The bad news from home made it difficult for him to concentrate. He receives news from home through a family friend in Boston, but has had no direct contact with his

family-mother, sister, and brothersince his arrival in America. After intensified bombing and recent advances by Russian troops, his family was forced to move to another village.

Thousands of Chechens have been killed and left homeless and the Russian army has incurred heavy casualties. Grozny has been devastated by Russian aircraft and artillery.

But Chamilov remains defiant and says the Chechens will never surrender to the Russians. He said Chechnya declared its independence in 1990 and that Mikhail Gorbachev was scheduled to sign an agreement to that effect August 19—the day he was overthrown. He said when Boris Yeltsin ran for election as president, he promised minorities living in former Soviet republics that he would not oppose their independence. "But later he launched an economic and financial blockade against us," he added.

He considers Chechen President Dzhokhar Dudayev a hero. "In 1991," he said, "when Dudayev was a Soviet general, he refused an order to bomb the Estonian capital. Although his son was badly wounded in the current conflict, he continues to lead our forces."

Chamilov said many Russians hate the Chechens because of Communist propaganda and oppression dating back to Chechnya's third battle for independence in 1918. He said earlier invasions by Ivan the Terrible, Peter the Great, and Czarist troops had been unsuccessful.

"In 1859 the Russian army killed 400,000 of 500,000 Chechens," he said, "then signed a treaty giving them limited autonomy. In 1944, Stalin ordered my entire nation exiled to Siberia; 200,000 died. In 1957 Nikita Khrushchev allowed us to return home. The Chechens are an agricultural people, but we are proud and want to have our own country."

He scoffs at Russian President Boris Yeltsin's claim that Chechen fighters and Dudayev are "criminals" and insists that Yeltsin is trying to divert attention from his flagging popularity in Moscow and elsewhere.

"The Chechen operation has been a disaster for Russia," he said. "The Russians lost more troops in one month than they lost in one year in Afghanistan. After Christmas, a friend called me from Argun and said they'd killed 1,000 Russians. In 1992, the Russians invaded neighboring Ingushetija and committed many atrocities. We have evidence of this on videotape."

Chamilov said Dudayev sent letters early last year to President Clinton and other Western leaders, asking them to send observers to Chechnya, but got no response. "I believe the U.S. government should cut off aid to Russia until Yeltsin withdraws his troops," he said.

The young Chechen said he is encouraged by a recent truce and mounting opposition to Yeltsin's policies within the Russian army and Parliament. He said he has faith that Chechnya will retain its independence: "In one of his books, Alexandre Dumas once called us 'the French of the Caucasus.' He said Chechens were born to be Republicans."

# Dr. Lassiter Receives Grant For Pilot Study

Dr. Donald Lassiter, assistant professor of psychology at Methodist, has received a federal research grant to study the effects of age and experience on the performance of general aviation pilots in the Cape Fear region.

The National Institute of Aging, a division of the National Institutes of Health, awarded Dr. Lassiter a \$50,000 grant last October. He and a team of assistants have constructed a research lab on the Methodist campus which features a computer-based flight simulator. Forty-two area pilots between the ages of 20 and 79 have agreed to serve as research subjects for the year-long study.

The pilots participating in the study will fly "courses" presented by a computer simulation program keyed to a Cessna 182, single-engine aircraft. Meanwhile, a second program will be running on a separate computer screen that will require the pilots to perform an additional task while flying.

The subject pilots will attend four training/practice sessions and three flying sessions. Each will fly eight courses—four easy and four difficult. During each 10-minute flight, letters may be shown on a separate computer screen above the flight simulator.

The primary task is to fly the prescribed course through a series of markers; to stay on course a pilot must stay within 10 percent of the specified air speed, altitude, and heading.

The secondary task is to react to the letters shown on the second screen. Pilots will get two letters, four, or none during the flight. If a letter shown is one that the subject was asked to memorize in advance, the pilot must quickly tap a "yes" key; if not, a "no" key. Each pilot's reaction time and flight performance will be measured and correlated.

By varying the difficulty of the courses and presenting the additional task, Dr. Lassiter and his research team plan to manipulate the mental workload demands placed on the subjects. The mental demands specifically addressed in the study are short-term memory, monitoring (or vigilance), and reaction time to make a decision.

Dr. Lassiter said he got the idea for his research project from a colleague at the University of Central Florida. He submitted the grant proposal in October 1993 and was approved a year later. He said he was "elated" that the project passed muster, noting that this was his

first grant proposal and that Methodist College is a relative newcomer in the field of psychological research.

Members of Dr. Lassiter's research team include: Gary Hinson, assistant professor of computer science: Michael S. Miller and David Z. Hambrick, recent Methodist graduates in psychology; and John Demos, a current psychology major. Others who have assisted in the research effort include Dr. M. Elton Hendricks. president of Methodist College; Dr. Anthony J. DeLapa, vice president for academic affairs; and Dr. John

F. Campbell, head of the Psychology Department.

Gary Hinson spent more than 500 hours developing the software program for measuring and recording reaction times during simulated flights. This involved synchronizing the flight simulation program with his program and devising the means to accurately record pilot performance in response to all the stimuli. The resulting data, which show pilot performance in relation to mental workload, will be statistically analyzed via an SPSS program.

Dr. Lassiter said the results of the study will be reported in both narrative and statistical form and will be made available to all the pilots who participate in the study. "We're operating at a theoretical level," he explained, "but I believe the results will be interesting and suggest directions for additional research. If indeed this turns out to be the case, we plan to write several journal articles and present at least one research paper at the annual meeting of the Human Factors and Ergonomics Society."

Other members of the research team say they have learned a lot, but have been awed by the vast amount of time required

to set up and monitor the human factors study.

John Demos, a senior psychology major from Dublin, Ohio, said he has learned three things: "that psychological research is difficult and demands patience...that perseverance is a must...and that there is no better way to understand the research process than by hands-on experience."

Michael Miller, a recent psychology graduate, said the study has made him appreciate the value of the education he received at Methodist and "the rigorous demands placed on psychology majors."

Zach Hambrick, another recent graduate, said his work as an assistant has taught him "the nuts and bolts" of research, as well as problem-solving and critical thinking skills.

Dr. Lassiter, the project director, plans to submit additional grant proposals based on the results of the current study. He describes his study as "just a beginning," noting that future aviation studies will be needed to investigate the relationships among age, expertise, and mental workload more thoroughly.

# USPTA Grants Accreditation To Tennis Management Program

The United States Professional Tennis Association granted accreditation to Methodist College's Professional Tennis Management Program December 7.

Directed by Dr. Theresa Warrell, the program combines a major in business administration from the Reeves School of Business with a concentration in professional tennis management. Through classes, workshops, and internships, students are prepared for careers as tennis professionals.

"We are proud to be associated with the USPTA," said Dr. Warrell. "Accreditation shows the world that our program meets the standards of excellence set by the world's oldest and largest trade association for tennisteaching professionals."

Methodist's program is the fifth in the U.S. to be accredited by the USPTA, but only the third offered by a four-year college. Accreditation standards require that Methodist's PTM graduates complete 30 weeks of internships and pass the USPTA certification exam.

Since its inception in 1988, Methodist's PTM program has placed 100 percent of its graduates in jobs as tennis professionals. Three 10-week internships, one each summer, put students in touch with tennis professionals in both the U.S. and abroad. In addition, a tennis professional visits the campus each semester to present an educational seminar to PTM students.

Dr. Warrell and her assistant Tom Maze, a Methodist College graduate, are both certified professionals. Having received USPTA accreditation, they said their next goal is to enroll more students. They are also looking forward to Spring 1995, when the college will begin construction of the Richard L. Player, Sr. Golf and Tennis Learning Center.



# Lynn Carraway Hones Marketing Skills

Lynn Moore Carraway, Class of 1971, is the Vice President and General Manager of WZFX-FM 99.1 "The Fox" in Fayetteville. On the way to this position, she has encountered some interesting turns and the emergence of a positive management philosophy that empowers those around her.

A religion major at Methodist, Lynn spent the first five years following graduation in church education ministry at Methodist churches in Lumberton, N.C. and Irmo, S.C. When she returned to Fayetteville, there were no positions available with the churches in town. Through a friend at church she got an interview with the mall manager at Cross Creek Mall. The rest, as they say, is history.

"One of the great advantages of a liberal arts school is that the skills I used in church work and the skills I needed to work in the marketing department were exactly the same," she said. "The only thing I had to learn was shopping center specifics."

She spent the next 17 years with Cross Creek Mall, moving from marketing assistant to marketing director. Awards and accolades followed, including the Maxi Award for community service and marketing excellence from the International Council of Shopping Centers. The Maxi is the highest award the organization presents.

Two years ago an opportunity presented itself at WZFX. Lured by the challenge, Lynn became vice president of marketing at the station in 1993. In less than a year she was promoted to her current position.

The challenge of running a radio station has been to "learn radio", said Lynn. "You don't just learn about a radio station, you have to learn how to sell it, learn about your specific format and learn how to decide what music to play," she noted. "I came in a non-radio person. That's been the challenge—to earn the respect of my employees, most of whom are long time radio people."

WZFX plays "urban contemporary" (rock, R&B, rap) music and consistently ranks No. 1 in audience share in the Fayetteville market.

When it comes to management style, Lynn has changed her philosophy over the years. Once a "my way only", tough



manager, now she tries to help her staff move up through the ranks.

"People may not come to you at their best in terms of skills or maturity," she observed. "I'm not a manager who likes to keep people down. I like to see people move up if they are willing to put in the time and work, and take in the training."

As a member of the Methodist College Alumni Association Board of Directors, Lynn takes an active part in the life of her alma mater. She believes the association should keep alumni linked to the College.

"The Alumni Association should be an ever-expanding network of alumni who are willing to share their expertise with others," she added. "As for the social end of it—maintaining friend-ships—I had not been to Homecoming in awhile. It was great fun. Networking can also keep people from getting lost. And we need to provide financial support for the College."

Lynn says she is proud to be a product of Methodist College, noting that the College "has an excellent reputation in the community." She added, 'It's a good school' is a remark I hear often and it is said with emphasis. There just can't be a higher compliment."

Lynn is very active in civic and professional organizations. She considers her association with the Fayetteville Chamber of Commerce to be exceptionally rewarding. She has served on the Board of Directors, chaired the Marketing Committee, co-chaired the Healthcare 99 Committee on Infrastructure and currently is on the Military Affairs Council.

In 1992 and 1993 she was named Outstanding Chamber Member of the Year for her work on the Fayetteville PRIDE campaign. The Pride campaign came out of the Chamber's Marketing Committee while Lynn was serving as chair.

"We are developing a sense of pride within the community and it has come so far," she explained. "Everyone has a sense of confidence in the future and excitement about the challenge. It's especially good when you hear it from people who are from out of town."

Her civic involvement extends beyond the chamber because of the radio station's commitment to the community. WZFX, along with Contact, developed the 'Teens Talk to Teens' help line.

"For 18 months we worked with funding and training teenagers age 16 to 21 to start the help line," she said. "It started in November. It opened at 5 p.m. and the phone rang almost immediately. It was satisfying to know the station had conveyed the message to the kids in the community that if they needed to talk to someone, call this number. Once we had the line up and running, a foundation matched a certain amount of money."

Lynn has some words of wisdom for today's business majors interested in careers in sales or marketing. "You won't start at 35 thousand! Realize that in almost every business, you are going to start at the ground level. Realize that the degree is not the end of the work—it is only beginning. The degree lays the foundation for what is to come."

# 'Honors Hall' Concept On South Campu

In the two years since Methodist College renovated the back row of 12 campus apartments and dubbed them "Honors Hall", student interest in living there has shifted from "lukewarm" to "definitely interested."

Built around 1960, the two-bedroom apartments were the first "dorms" and housed groups of four each for three academic years before Cumberland and Garber halls

were completed in 1963. They were later used to house married students, faculty, and staff. Two smaller apartments buildings in front of the largest building served much the same function,

but have also housed everything from the infirmary to the Music Department to Financial Aid.

In the spring of 1993, when it became apparent that the four residence halls could not accommodate everyone by the fall, Vice President for Student Affairs and Dean of Students Mike Safely proposed creating "a new habitat" to reward upperclassmen with good academic performance.

It was determined that 44 students could be housed in the apartments, with one unit being reserved for a hall director. After tenants were given notice, the college painted, carpeted and renovated the 12 apartments; new furniture was purchased and kitchen appliances upgraded.

Dean Safley first proposed that the apartments be offered to upperclassmen with grade point averages of 3.0 or higher. The complex would be co-ed, with one female resident adviser and one male. His superiors agreed and implemented a \$200 a year surcharge beyond the \$1,450 charged for a regular dorm room. Since utilities were included in the rent, the five-room apartments originally cost each resident only \$181 per month.

This school year, Honors Hall costs \$2,000 per year (\$400 more than a typical dorm room); but students who live there are not required to eat in the college cafeteria. That saves them the

cost of board-\$2,150 per year.

When the 1993-94 school year opened, Honors Hall was about 10 students short of being filled, so the G.P.A. requirement was lowered to 2.5 and the rooms were filled. In the fall of 1994, the demand rose and a waiting list developed for Honors Hall.

One thing is clear. The students who now live in Honors Hall consider it a step up from the residence halls and seem to enjoy living there. They say it's quieter and more spacious than the regular residence halls.

Mrs. Wanda Foster is the hall director. She and husband Ron, who is the college's physician assistant, live ir downstairs apartment with their teenage son. They also have three grown sons.


Why would the Fosters, a couple in their late 40's, sell their four-bedroom home in College Lakes and take up residence in an apartment complex with 44 college students? "We wanted to tr something new," said Ron.

Wanda Foster says being on call 24 hours a day has meant some loss of privacy, but adds, "What we have given up in privacy we have gained in commi nity. We've enjoyed the opportunity to established mutual trust with members the younger generation. The residents

Honors Hall are an older, more mature group and can usually work out their own problems."

Ron Foster describes Honors Hall as "an excellent experiment in community living" and adds: "To raise children is one thing. To live among young adults filled with the excitement, hopes, and dreams of the full life ahead of them is yet another. I suppose what I like best at Honors Hall is the front porch sessions that take place in the fall and spring when students meet on the stoops or around the picnic table to engage in

intellectual conversation and debate.
They are exciting and extremely lively."

Honors Hall residents generally like their apartments, resident advisers, and the Fosters. Some feel the G.P.A. requirements should be raised to 3.0.

In a recent survey, they served up the following comments:

Jason Williams: (sophomore from Stuart, Fla.)—"I would move the honors hall residents into the new dorm and make it an honors dorm. Let the rest of the students take notice of motivated students, instead of isolating us from the

rest of the campus."

Dan Devlin: (junior from Fayetteville, N.C.)—"I like the privacy, seclusion, and isolation."

Alvy Styles: (freshman from Dublin, Ireland)—"This is a lot better than 'the train station' (her term for Weaver Hall). People from the other dorms come over here to study."

Darlene Dykas: (sophomore from Concord, N.C.)—"The best thing is being off the meal plan and being able to cook my own food."

Jodie Young: (*sophomore from Wade*, *N.C.*)—"Having a kitchen and living room makes it more 'home-like'."

Daniel Barros: (sophomore from Edison, N.J.)—"Ron and Wanda Foster are very helpful and understanding. They're there for us when we are confronted with a problem."

Britt Morton: *(junior from Apex, N.C.)*—"My resident director (Wanda Foster) is great. She gets people to fix what is broken the next day."

Dean Safley says Methodist will shift "Honors Hall" to one of the new residence halls if and when the apartments are razed to make way for a proposed office park.



# MC FACULTY, STUDENT TEACHERS FORGE UNIQUE

Eighteen students teachers from Methodist College began their spring semester methods courses at William T. Brown Elementary School in Spring

Brown is a new facility and is Cumberland County's first year-round school. It was one of two elementary schools which were built last year with federal money on federal (Fort Bragg)

Dr. John Griffin, county schools superintendent, allotted the group from Methodist a spare classroom—Room 308 on the 4th, 5th, and 6th grade hall. Principal Rachel McClellon gave the Methodist faculty and students full access to Brown's teachers, staff, students, and educational materials.

This first-of-its-kind partnership allowed Methodist's student teachers to observe teaching methods and classroom management techniques before they began their respective student teaching assignments. "This type of interaction gives student teachers a whole new perspective," said Dr. Lancaster.

The student teachers videotaped and critiqued each other's teaching performance. They observed Brown's teachers and students in their classrooms, learned how the principal manages an innovative "pilot school", and discussed what they had observed with their professors.

To fully appreciate Brown Elementary, one must visit the facility, which currently serves 500 students. All classrooms have telephone/intercoms, TV monitors/clocks, and their own restrooms. There are two fully-equipped computer labs. The media center is sectioned off according to reading levels; students search for books on computer terminals. Westminster chimes have replaced bells. There is even a "parent room" where volunteers can work.

A TV control room in the main office area allows the principal to observe and converse with teachers and make schoolwide announcements. The media coordinator can feed videotapes to selected classrooms at predetermined times. The copy machine in the teacher

workroom is both elaborate and smart; it keeps tabs on paper usage via the access codes assigned to teachers and staff.

During a first-day tour, Principal Rachel McClellon relayed some interesting facts about the school. Teachers of grades K-3 have self-contained classrooms, while 4th-6th grade teachers "teach to their forté in teams." Teachers move, not students.

Brown has a full-time guidance counselor and full-time art, physical education, and music teachers. Fifteen minutes is set aside daily after morning announcements for "schoolwide writing." The school has a Beta Club, Art Club, Music Club, and chorus.

Students are automatically considered for an incentive scholarship when they apply to the college. When final high school transcripts are received, the Office of Admissions will reevaluate the student and increase any applicable scholarships or award scholarships to those students who now qualify.

This Incentive Scholarship program applies to all students who apply for admission to Methodist College beginning with the Fall 1995 Day Program.

# CHARLIE GADDY ASKS WINTER GRADUATES TO GET INVOLVED, MAKE A DIFFERENCE

Winter graduates of Methodist College were challenged December 16 to make a difference in the world by voting, serving their communities, and showing concern for others.

The commencement speaker was Charlie Gaddy, former news anchor at WRAL-TV in Raleigh and a former trustee of Methodist College. He said today's college graduates have the power to make the world of tomorrow much better than it is today.

In the first half of his speech, Mr. Gaddy discussed the importance of the press in a free society—as a watchdog over government and a conveyor of truth and vital information. He decried the "confounding arrogance" shown by some in the news business and "a dangerous turn" in television news toward "show business techniques," as exemplified in programs like A Current Affair or Inside Edition.

Mr. Gaddy said the press can stand some self-analysis and criticism, and that consumers should make their views known to their local newspapers and TV stations.

December graduates were also addressed by Reverend Tommy Smith,

Fayetteville District Superintendent, North Carolina Conference of the United Methodist Church. Reverend Smith said the graduates would be tempted in the world, just as Jesus was tempted in the desert following his baptism.

"Remember your river experience," he said. "You'll need it to live through the tough times. Remember your faith and aspirations...Jesus said pay attention to what's inside, that which won't let you rest or give up...Faith is what holds us together."

Methodist College awarded degrees to 98 persons at its winter commencement. Dr. Elton Hendricks, college president, also presented two honorary doctorates—a Doctor of Divinity to Reverend John Thomas "Tommy" Smith of Fayetteville, and a Doctor of Humanities to Mr. Charlie Gaddy of Raleigh.

Dr. Hendricks presented the Sam Edwards Award to Ricky Darwin John, denoting his selection as the outstanding Evening College student of 1994.

Mrs. Julia Abner, a native of Cuba, presented a Cuban flag to the college. Since 1985, foreign-born graduates

have presented the flags of 40 nations to Methodist College at the spring and winter commencements.


Thirty-seven members of the winter class graduated with honors—16 "cum laude," 11 "magna cum laude," and 10 "summa cum laude."

### Monarchs Excel At Mason-Dixon

The Methodist College men's track team turned in a third place finish, but set a school record for most points scored in a meet at the Mason-Dixon Conference Track and Field Championships at Virginia Tech University.

The Monarchs had 31 performers named to the Mason-Dixon All Conference Team and five Monarchs tabbed as individual conference champions.

On the men's side, Jamelle Ushery won his third Mason-Dixon Conference Championship in the 55-meter hurdles, also set a school mark, coming in second in the 400-meter dash with a time of 50.9. Ushery was also named All-Conference in the long jump (third, 21'9"), and the high jump (tied for fifth, 5'10").

Hamilton Cuthrell won the 55-meter dash with a time of 6.43, breaking his old mark of 6.44 set at the USAir Invitational at East Tennessee State in Johnson City, Tenn. Cuthrell, ranked fifth in the nation in the 55 meters, also set a school record in the 200 meters with a time of 22.5 while coming in second. Another winner on the men's side was Bjorgvin Fredriksson in the 5,000 meters, with a time of 16:02. The freshman also set a school record in the 1,500 meters with a time of 4:09, while finishing second.

Bradley Hicks took the pole vault title with a jump of 14'0".

The women's team tallied 25 points and came in fifth place, just one point out of fourth. The Lady Monarchs were led by Karen Murphy who won her first high jump title with a mark of 5'2", a school record. Murphy, a senior, is a four-time Mason-Dixon All-Conference performer.

Other top finishes on the women's side were Jody McIntyre and Heather Fisher in the shot put. McIntvre, the former 1990 Canadian Junior National shot put champion, came in second with a throw of 36'6" and Fisher in fourth with a throw of 35'3".


