It is with great pleasure that I reflect on 2003 in the life of Methodist College, if for no other reason than we graduated 275 fine young men and women to go out into the world and make a difference.

Methodist College continues to grow to meet the challenges and demands of the world economy. With the graduation of our first seven Master's degree candidates, the Physician's Assistant Program has a solid foundation. The College can now turn its sights to future graduate degree programs, and currently has two in the final planning stages.

New concentrations in Biology, Business and Computer Science, and a new major in Occupational Environmental Management will allow Methodist College students the opportunity to tailor their degrees. 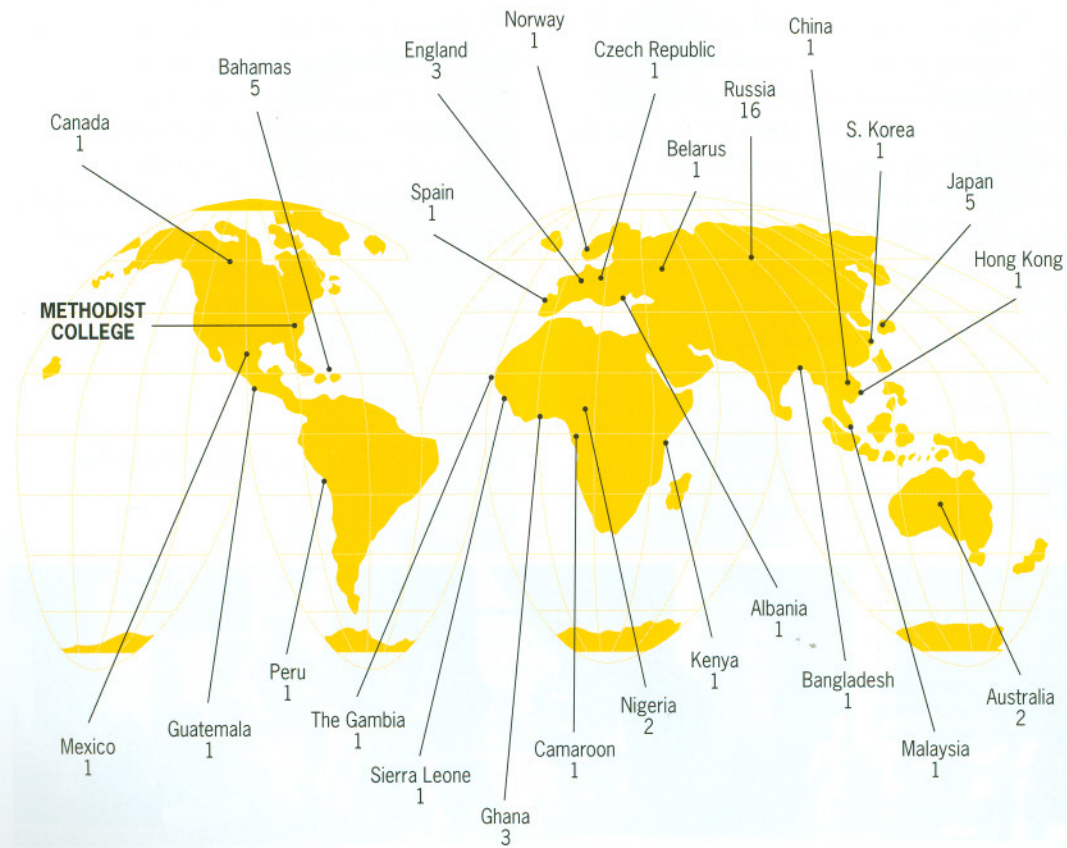


Fall 2003 Enrollment



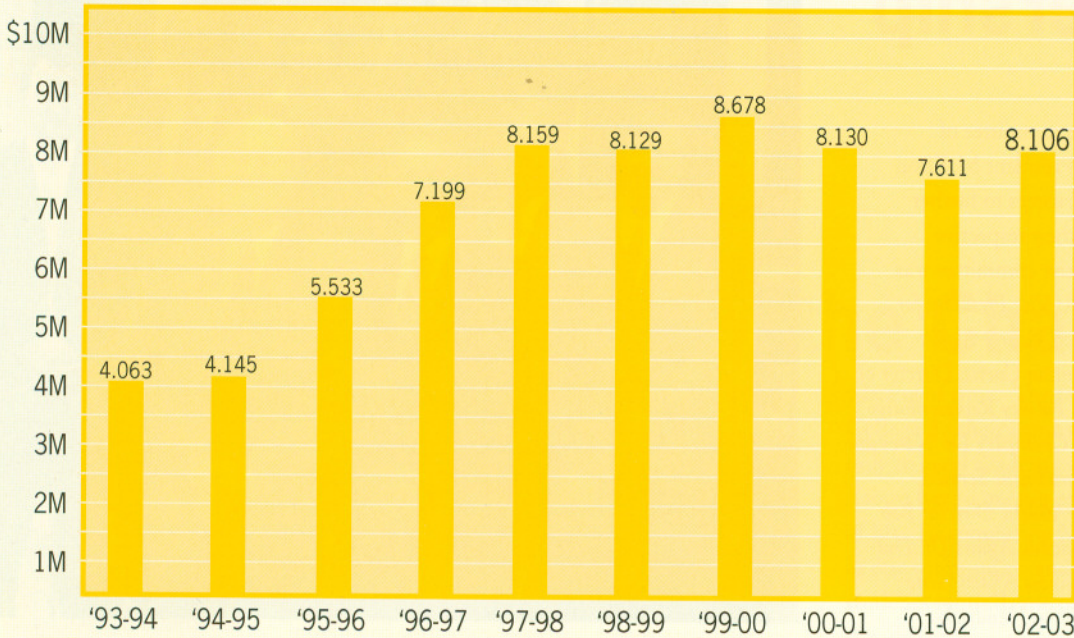

Endowment History

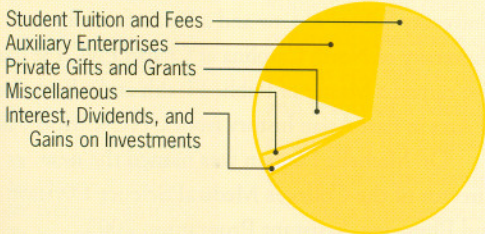

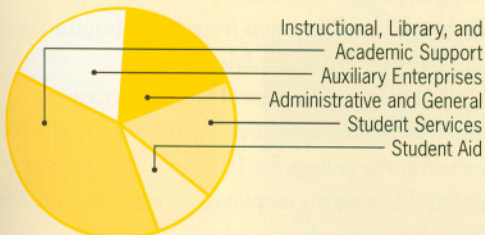

Expenditures

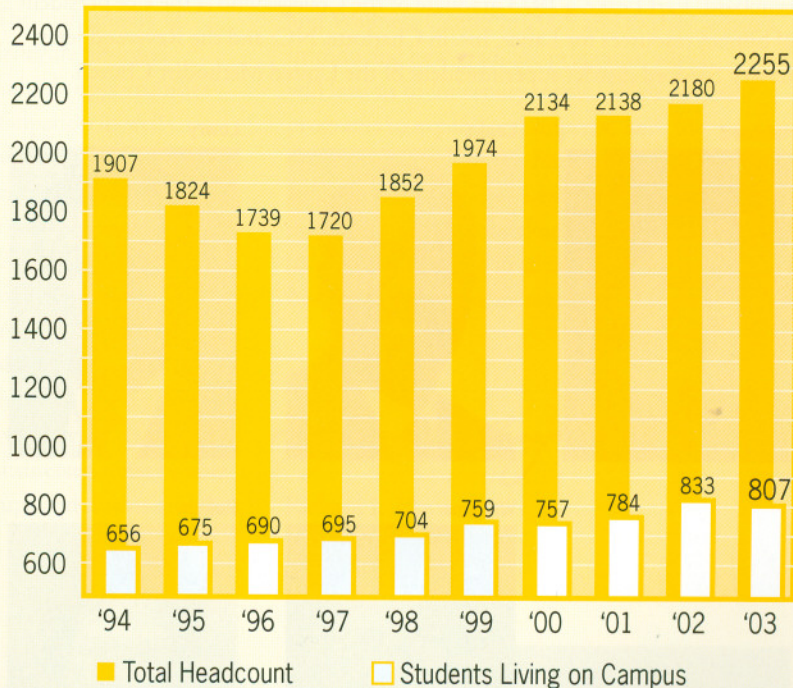

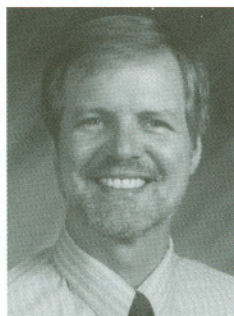

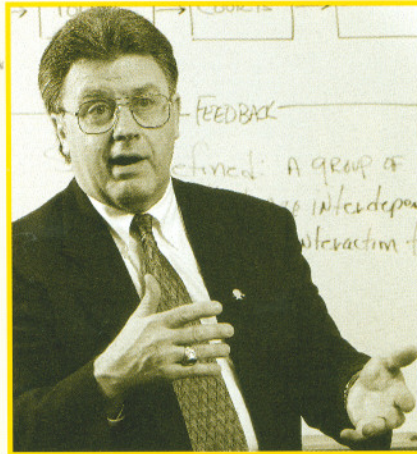

- * Dr. J. David Turner, assistant professor of Speech and Mass Communication, along with authors Dr. Willis Watt, C.B. Crawford, Mahboub Hashem and Eric Krug, recently published the second edition of the textbook, *Speech Communication: Theories and Practices* published by McGraw-Hill Companies.
- * Director of the Division of Professional Studies, Dr. Willis Watt:
 - Published an article in the *Journal of Leadership Education*, Summer 2003, Vol. 2, No. 1, entitled "Effective Leadership Education: Developing a Core Curriculum for Leadership Studies;"
 - Was appointed Review Editor for the *Journal of Leadership Education*;
 - Had various poems published in print or cassette/CD format with Watermark Press, Noble House and the *Fayetteville Observer*.
- * Director of the Division of Fine Arts and composer Dr. Keith Dippre premiered his new piece *Pilgrim's Blues* in Northampton, MA, commissioned for the Jonathan Edwards Tercentenary.
- * Art Professor Peggy Hinson won the First Place Award among 350 entries in March 2003 in the "Third Annual Current Works, A National Artist Competition" held at Fayetteville State University.
- * Dr. Peter C. Murray published *Methodists and the Crucible of Race, 1930-1975* with the University of Missouri Press.



- * Dr. Darl H. Champion, Sr., reviewed two community college programs in criminal justice for the *Massachusetts Board of Higher Education*.
- * Assistant Professor of English Vicki Erben published an article in *All Together Now*, a magazine focusing on inclusiveness in education.
- * Dr. Maurice Godwin was:
 - Selected as Top Gun of the month and interviewed by the *Public Safety Journal* in June 2003;
 - Interviewed by Liza Porteus, Fox News, in June 2003 on the subject of serial killers;
 - A guest expert commenter on WRAL-TV for the Michael Peterson trial.
- * Dr. Richard Walsh published his book *Reading the Gospels in the Dark: Portrayals of Jesus in Film*, (Harrisburg, PA: Trinity Press International, 2003); and presented at the national meeting of the American Academy of Religion and the Society of Biblical Literature a paper entitled "Three Versions of Jesus."
- * Dr. Michelle Heinan published nine articles in the *Advisor Forum of The Clinical Advisor for Physician Assistants*.

Milestones

- * The College's 127th Southern Writers Symposium returned to Methodist College on September 19 and 20th. Over 60 people attended this year's event, themed *Region*, which featured nine speakers and 30 scholarly presenters, including Lucinda MacKethan, John Shelton Reed, filmmaker Gary Hawkins, and storyteller Carman Deedy. Attendees came from as far away as Spain, Illinois and Mississippi.
- * Methodist College's first seven master's degree candidates graduated from the Physician's Assistant program during the winter commencement ceremony on December 12, 2003.
- * The spring graduation marked a new tradition with the introduction of the official Methodist College mace—derived from the medieval period as a symbol of authority of the body that governs an institution. The top is adorned with the United Methodist symbol of cross and flames; the globe features the college seal and is symbolic of the worldwide service the College has rendered, while the ribs of the shaft represent eight groups that support the College: the United Methodist Church, trustees, administration and staff, faculty, alumni, students, parents and public and private groups. The cotton blossom at the bottom of the mace is a reminder of the inaugural address given by the first president of Methodist College, Dr. Stacy Weaver, entitled "From Cotton Field to College." The streamers contain words from the college's alma mater. The mace was given to the college by R. Parker Wilson, distinguished service professor, emeritus, in memory of his father, Martin Morehead Wilson, and for the glory of God.
- * Joining with more than 200 other private institutions across the nation, Methodist College chose to participate in the nation's first Independent 529 Plan to offer an income tax-advantaged way for families to save for tuition.

Awards/Honors

- * Men's Basketball Coach David Smith was recognized as the 2002-2003 Dixie Intercollegiate Athletic Conference Coach of the Year.
- * For the first time in 8 years, the Methodist Lady Monarch women's soccer team had a player gain All-American honors. Senior goalkeeper Keri LaSalla was selected in December as a third team NCAA Division III All-American by the National Soccer Coaches Association of America (NSCAA).
- * College President M. Elton Hendricks was honored by the Fayetteville Chamber of Commerce with the 2003 Chairman's Award. The Award recognizes his significant service and contributions to the greater Fayetteville community.
- * For the second straight season, Methodist College finished second in the Dixie Intercollegiate Athletic Conference (now USA South Athletic Conference) President's Cup standings.
- * The Women's Golf team captured the 2003 NCAA Division III Championship; and the Men's Basketball team became 2003 DIAC co-champions.
- * Former NCAA All-American and Olympian, Methodist College cross country and track and field head coach Halcyon "Tudy" Blake was inducted into the Public Schools Athletic (PSAL) League Wingate Funds Hall of Fame in New York City in the fall of 2003.
- * Methodist College was selected to host the National NCAA Division III Women's Golf Championship in May 2005 at Mid-Pines Golf & Country Club.
- * Four of the twelve cadets commissioned by the Methodist College Army ROTC

program were designated Distinguished Military Graduates, placing them in the top 20% of cadets nationwide.

- * The college was pleased to present three Methodist College Medallions in 2003.
 - The college honored Dr. Mary Dix McDuffie '75, executive director of the North Carolina Center for the Advancement of Teaching, by awarding her a Methodist College Medallion. McDuffie also delivered the spring commencement address.
 - Dr. Loleta Wood Foster, a licensed psychologist and owner of Assessment Counseling and Consulting, was presented the Methodist College medallion for her dedication and service to the College, the community, and her clients. Foster, a College trustee since 1993, also gave the winter commencement address.
 - The Florence Rogers Charitable Trust and trustee Nolan Clark were also honored at the winter graduation with a medallion. Under the direction of Clark and John Tally, the foundation has been instrumental in supporting such noteworthy programs as the CARE Clinic pharmacy and the Methodist College physician assistant program.

Distinguished Service Professor of French and Head of the Foreign Languages Department Elaine Porter retired after 40 years of teaching; Associate Dean and former history professor Dr. Robert Perkins retired after 29 years; Vice-President for Academic Affairs and former professor of education, Dr. Anthony DeLapa retired after 14 years; and Assistant to the President for Church and Community Relations and former education professor Dr. Tryon Lancaster retired after 12 years. Dr. Suzan Cheek, political science professor and director of the Tally Leadership Center, retired after 16 years of service.

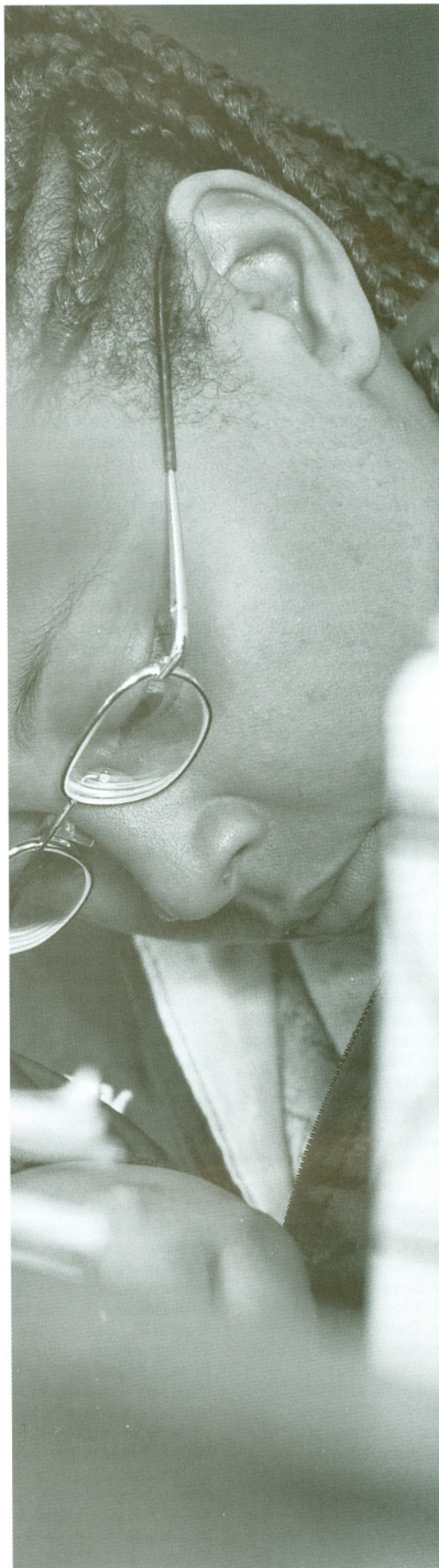

Seeds on Good Soil, A New Season

Campaign Update

Methodist College continues to improve in reputation and status and to recruit more academically talented students. With this kind of progress, the need to provide high quality facilities, technology and programs also increases. To create a campus environment that will continue to attract strong students and faculty, the College is in the process of securing greater financial resources and improved facilities through its *Seeds on Good Soil, A New Season* Campaign.

This ambitious campaign marks the third time in the College's history that the Board of Trustees has authorized such an endeavor. The campaign, announced on May 2, 2002, seeks to raise \$11.4 million for:

- * Building a \$5 million state-of-the-art addition to the existing Science Building;
- * Constructing a \$3.5 million Fitness and Wellness Center;
- * Adding \$1.85 million to the College's Annual Fund (over a four year period); and
- * Adding \$1 million to build the College's endowment.

The current Science Building was constructed in the early 1960s. While the building is still structurally sound, and has many useful years of life remaining, the demand for additional student capacity, new programs, and laboratories accommodating modern science has made it imperative to expand the physical facilities.

The addition to the Science Building will house seven state-of-the-art laboratories for Biology and Chemistry, offices,

stockrooms, an elevator and a multi-purpose room. As part of the construction, several older labs in the existing Science Building will be converted into classrooms.

A new fitness and wellness center is needed to meet the needs of non-intercollegiate student-athletes. Currently, the only facility on the Methodist College campus where students can work out and/or play intramural sports is the March F. Riddle Physical Activity Center. The center gives priority to athletic teams that often do not finish practice until well into the evening. Thus, on any given night, more than 100 students wait for court time, gym time, etc.

The new Fitness and Wellness Center will house a regular basketball court and two cross courts, a walking track, an exercise and weight lifting area, lobby, bathrooms and offices. When the new center is complete, the space it currently occupies in the Riddle Center will be converted into offices and laboratory space to support the College's nationally accredited Athletic Training program.

The Annual Fund and the College Endowment are important components of this campaign. The Annual Fund provides income for day-to-day operational expenses, scholarships, library materials, athletic equipment, computer resources, laboratory upgrades, and upkeep of grounds and facilities. The College's Endowment works like a savings or investment account, with the earnings being used to provide stable income for scholarships or professorships.

At the end of 2003, Methodist College had raised a total of \$8.4 million toward its \$11.4 million goal. Good news came

in the month of December with a million dollar gift from the Nimocks family towards construction of the Fitness and Wellness Center, which will bear their name. The gift marked the third of its kind made to the College in its 48-year history.

There were other campaign success stories during 2003. Thanks to the generosity of individuals and foundations, the campaign reached the \$2 million mark in gifts and commitments received for the College's endowment, twice the amount of the goal for this area. More than 260 individuals, corporations and foundations, including more than 100 of the College's alumni, gave or committed gifts of \$1,000 and above, making them eligible for the Honorable Monarch Society.

Thanks to the support of our boards, faculty, staff, alumni, parents, friends, corporations, foundations, organizations, the United Methodist Church, the Independent College Fund and even current students, we have made good progress on this campaign. There is still much to be done to complete the campaign and meet our goal of breaking ground in the summer of 2005 to build the addition to our Science Building and our Fitness and Wellness Center.

We look to you to join us in the field, to help us plant the seeds and know you had a hand in producing the amazing harvest only education can bring to a region, to a nation, to the world.

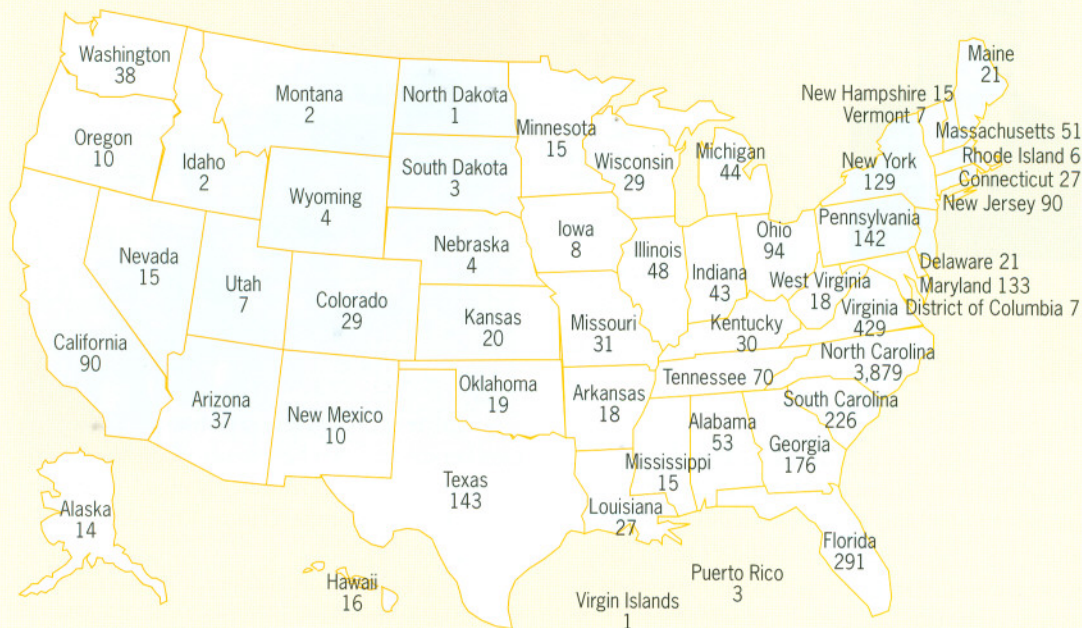

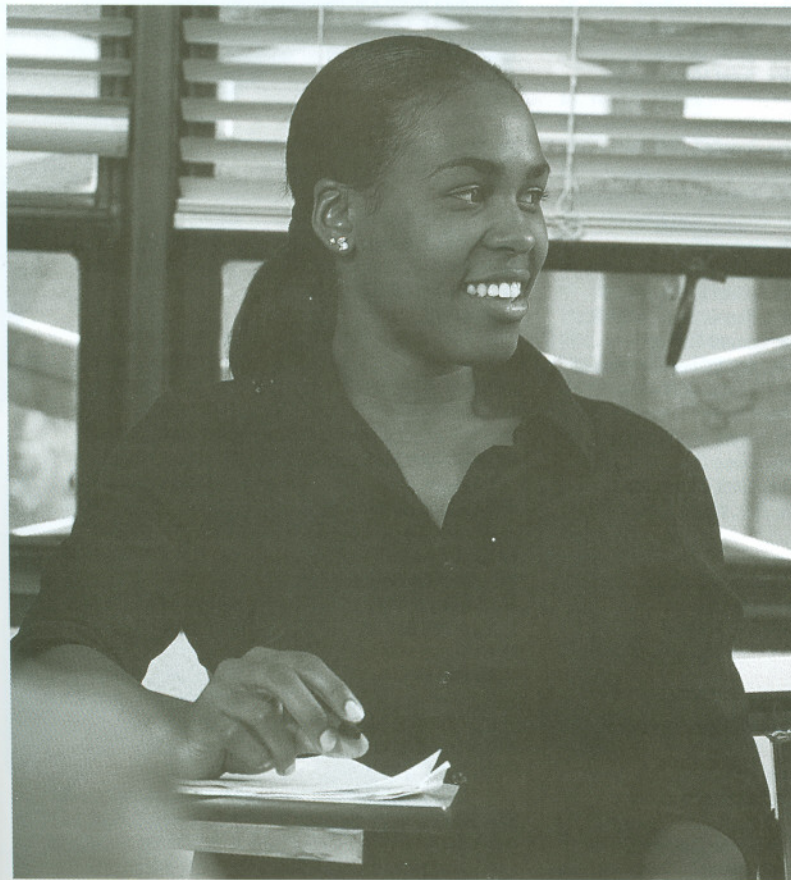

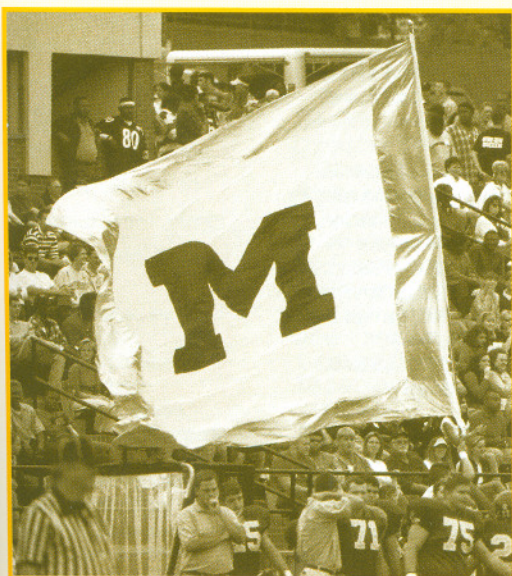
Special Programs

- * Dr. Genna Rae McNeil, a distinguished scholar, historian, author and archivist, spoke at spring 2003 convocation on the role of African-American women in the civil rights movements. Her presentation, part of Black History Month, was titled, "Sisters in the Struggle: Finding Your Voice and Using It." Dr. McNeil is a member of the History Department at the University of North Carolina at Chapel Hill and authored *Groundwork: Charles Hamilton Houston and the Struggle for Civil Rights*.
- * Methodist College graduated 138 students at its 40th spring commencement on May 10. Dr. Mary Dix McDuffie, a 1975 graduate of the College, was the keynote speaker. McDuffie provided five steps to lifelong fulfillment: *Love your family, nurture your friends and faith; Do the right thing; Remember that attitude is everything; Give everything you do, everything you've got; and Cherish laughter and joy.* Earlier in the day, spring baccalaureate speaker, Dr. William Simpson, challenged graduates to boldly state to employers, their parents, the college and the world that "I am here."

"Today, as you travel across this bridge, or stage, you will be ready to begin a new phase of life," she said. "It is what you do after you cross it that matters most." 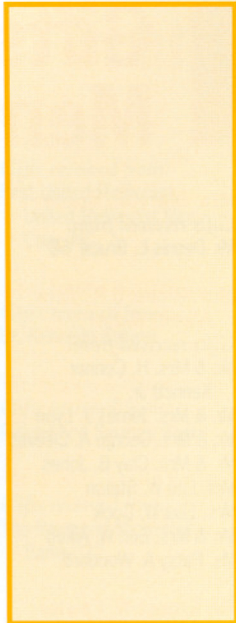

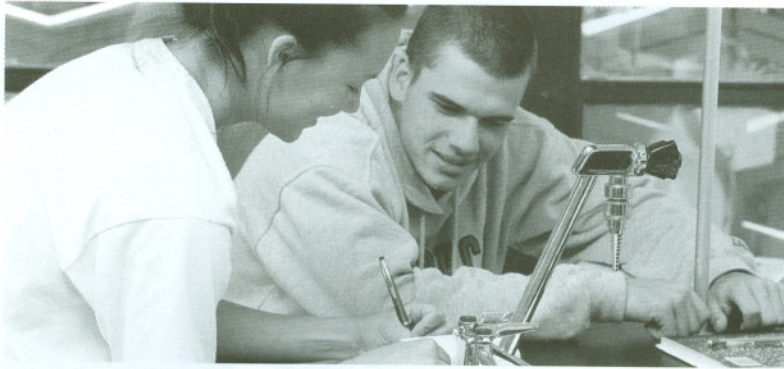

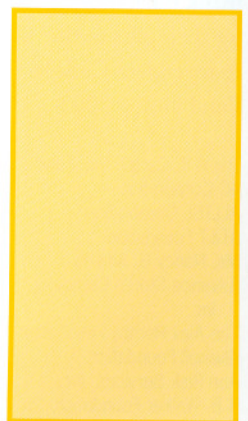
