MESSAGE FROM THE PRESIDENT

Dear Methodist University Family and Friends,

2006 was a wonderful year in the life of Methodist University. In the spring, our Physician Assistant program, one of only four in the state, celebrated its 10th anniversary. Our athletic teams then finished the 2006 spring sports year with four USA South Athletic Conference Championships, four Coach of the Year awards, and three Player of the Year awards.



In late summer, we celebrated not only our largest traditional freshman class of 417 incoming students, but also our largest class of Presidential Scholars, at 171 students, in the history of Methodist University. Our big celebration, however, occurred in November, with the observance of our 50th anniversary from charter, and the move to University status.

"Should we become a university?" was the question on everyone's mind in 2006. There were valid arguments for and against the change, and there was the greater question of what our new name would be if we did become a university. We looked to sister institutions—Campbell, Chowan, Elon, High Point, and Wingate—who had successfully made the transition as we weighed our decision. One argument for the

change was the need to differentiate ourselves from technical institutes who have adopted the "community college" name in recent years. I am pleased to share that, in the end, the Board of Trustees unanimously approved the name change from Methodist College to Methodist University on Nov. 1, 2006 as a reflection of the growth of the institution—from 86 students, 12 faculty, and 11 majors in 1960 to over 2,100 students, 350 faculty, and staff, and 70 majors and concentrations today, including a vibrant international program with 72 students from 37 countries.

As I reflect on the history and accomplishments of our first 50 years, it is evident that this institution was founded and nurtured by a group of special individuals who went above and beyond the call. Those same types of individuals exist today, on our Board of Trustees, administration, faculty and staff, who will guide this institution forward over its next 50 years. My wife Jerry and I are deeply honored to have been a part of this wonderful family for the last 24 years, and thank you for your friendship and support.



MESSAGE FROM THE CHAIRMAN

Dear Friends,

On behalf of the Board of Trustees, I am pleased to report that Methodist University continues to grow and, as President Hendricks mentioned in his message, Methodist has now formally changed its name to Methodist University. Methodist began classes in 1960 with 86 students. Currently we have over 2,100 students, almost 900 of whom live on campus. Many of our other students live in the Fayetteville area and 65 percent of our students are from North Carolina. However, it is noteworthy that we have students from 42 states and 37 countries.



Two new apartment-style Residence Halls, a Fitness Center and Science Building addition were either in the process of completion or were completed during 2006. The residence halls were the result of a \$24,000,000 bond issue which also refinanced existing debt and provided initial construction funds for the Fitness Center and Science addition. A capital campaign which raised almost \$15,000,000 provided the remaining funding for the Fitness Center and Science Building addition, as well as endowment and operating funds.

We now have three master's degree programs: a Professional MBA program emphasizing Professional Golf Management, a Master's in Justice Administration and a Master's in Physician Assistant studies. The Physician Assistant program, one of only four programs in North Carolina, currently receives 10 or more applications for every first year space available.

Methodist University has an annual operating budget exceeding \$40,000,000 and 350 full-time faculty and staff. The SAT score for the last two freshman classes has averaged 1,000 and this year we have 15 applicants with SAT's over 1,400. This enables us to become more selective in the quality of students we accept. In this connection, the Board of Trustees has asked the faculty and staff to pursue a culture of excellence in all activities of the University. The quality of our students is at a level that demands we encourage faculty and staff to strive for the full development of each student's potential.

Methodist University is beginning to reach a new level in all aspects of student life. The Board of Trustees is aware that globalism is not around the corner but is already here and it is our mission at Methodist University to produce students able to compete effectively in the new global society. This is not just a worthwhile goal but it is an essential goal. The Board of Trustees is very grateful to all who have supported Methodist University, and we and our graduates will be forever indebted to you.

Dr. Wenda Johnson, dean of the School of the Science and Human Development and chair of the Teacher Education Committee, said she is "proud to have gained this status, proud of our students, proud of our faculty and staff, and thankful for the support of our administration."

ON BEHALF OF THE STUDENTS, FACULTY AND STAFF, AND THE ADMINISTRATION AT METHODIST UNIVERSITY, WE ARE PROUD OF YOU, DR. J. AS DR. Dr. Johnson arrived at Methodist on Aug. 14, 1991 and served as chair of the Physical Education Department and professor of physical education from 1991-2004. In 1994 she became assistant dean for Academic Affairs and head of the Interdisciplinary Studies (IDS) program. In 2004 she was named dean of the School of Science and Human Development; while maintaining her status as a tenured faculty member in the Department of Wellness and Exercise Science.

Dr. Johnson became Methodist's interim vice president for Academic Affairs on June 1, 2006 and was one of three finalists for the position of vice president for Academic Affairs. She was slated to become associate dean to Dr. Delmas S. Crisp, Jr., Methodist's new vice president for Academic Affairs, upon his arrival on June 1, 2007.

During her sixteen years at Methodist and throughout her teaching career, she was active in several professional organizations, presented papers at professional meetings, and published a number of articles in scholarly journals. In 1993-94, she won three grants totaling \$141,000 for Methodist—grants which provided a Human Performance Laboratory, a Substance Abuse Education and Prevention program, and human anatomy models.



Dr. Johnson believed in community service and worked as a volunteer with the Cumberland County Guardian Ad Litem program, Cross Creek Presbyterian Church's Fellowship and Missions Committee, Special Olympics, and Habitat for Humanity. She is survived by her mother, Mrs. Arvis Johnson of Haines City, Fla., and a brother, Mr. Francis Duane Johnson of Auburndale, Fla.

Her warmth and concern for others endeared her to her peers and the students whose lives she touched.

Dr. Greg Combs, assistant professor of sport management, was elected chair of the Fayetteville Area Sports Commission. Dr. Combs launched a sport video analysis company called "Hall of Fame Productions" to provide more opportunities for MU sport management students. He presented at the International Conference of Sport Business and Entertainment and was featured in the October 2006 edition of *Sports Illustrated*.

The Department of Modern Languages and Literature announced two new overseas study programs, one in Sevilla, Spain from May 12-June 11, 2007 and the second in Rimini, Italy from May 26-June 23, 2007.

Mary Deyampert-McCall, professor of social work, led a community task force including community leaders, to examine child homicides in Cumberland County. After a year and a half, they have issued a report with recommendations for follow-up. She also chairs the County Department of Social Services Board of Directors.

Dr. Keith Dippre, associate professor of music, was presented with the Academic Hall of Honor award at his alma mater, Azusa Pacific University, Azusa, Calif., on Oct. 28, 2006. On Nov. 3, his commissioned piece "Attacca 1956" premiered with the Fayetteville Symphony Orchestra to commemorate the 50th anniversary of Methodist University.

Dr. Juanita Heyward, associate professor of elementary education, graduated from the Institute for Community Leadership on April 18, 2006. She toured Hong Kong and Beijing in July. "Yes," she said, "I climbed the Great Wall!"

Twenty-two international students from Methodist University met her Majesty, Queen Noor of Jordan, at the 50th anniversary gala for the Fayetteville Symphony Orchestra on Oct. 5, 2006. Queen Noor serves as president of the United World Colleges (UWC).

Wendy Vonnegut, Esq., associate professor of legal studies, met with Justice Sandra Day O'Connor at the Convocation of Elon School of Law. She also received a full tuition scholarship to Vermont Law School to study environmental litigation. The scholarship was awarded to only three directors throughout the country. Additionally, she was elected second vice president for the Southern Association of Pre-Law Advisors, which covers the states of Virginia, North Carolina, Georgia, Florida, and South Carolina..

Dr. Larry Wells, assistant professor of music, won a position in the Fayetteville Symphony Orchestra and completed his doctor of musical arts in December 2006.

Dr. Drew Ziegler, associate professor of political science, became the new director of the Community Leadership Training program for Cumberland County.

Tom Austin, baseball coach, was selected 2006 USA South Athletic Conference Coach of the Year.

Bob McEvoy, director of Athletics, completed a two-year term as president of the USA South Athletic Conference. He completed a four-year term as South Region chair of the National NCAA III Men's Basketball Committee and a two-year term as an NCAA facilitator at Regional Leadership Conferences in Dallas, Chicago, Pittsburgh, and New York.


The women's golf team won their ninth-straight national championship at the 2006 NCAA Division III Women's Golf National Championship in Howey-In-The-Hills, Fla., at the Mission Inn Resort. Charlotte Williams won the individual championship for the second consecutive year on the way to the team's nineteenth championship.

The baseball, softball, women's tennis, men's golf, and women's soccer teams won USA South Atlantic Conference Championships. Twenty-five athletes were named to USA South All-Conference First Teams while 71 student-athletes were named Academic All-Conference.




Fall 2006 Enrollment




Fall 2006 International Students

Expenditures



Campaign ■ Update

Fundraising for the *Seeds on Good Soil, A New Season* campaign drew to a close in late 2006. This campaign, which raised a total of \$14,739,839, marked not only the largest in Methodist University's history, but is believed to be the largest campaign raised with private dollars in the history of Cumberland County, North Carolina.

The campaign, which the Board of Trustees approved in October 2001, was publicly announced in May 2002 with an \$11,000,000 goal. With early success in the area of endowment, the goal was increased over time to \$12,850,000. The campaign focused on three primary areas: an addition to the Science Building, a Fitness Center, and the endowment. Following is a snapshot of funds raised:

"We are proud to have reached this milestone in the life of Methodist University," said President M. Elton Hendricks, adding "It would not have been possible to raise this amount of money without the leadership of co-chairs Bob Allen and Ramon Yarborough, as well as a strong Board of Trustees who gave a significant amount of the total raised."

Construction on the Fitness Center and Science Building addition began on October 31, 2005, and is slated to be completed in May 2007. The Fitness Center, designed for the use of the general student body as well as intramurals, houses a full-size basketball court, a walking track, work out area with equipment, and a smoothie bar. The Science Building addition contains 11 biology and chemistry laboratories, a tiered classroom, two laboratory prep rooms, a great room, and 10 offices. It will also contain Methodist's new Environmental Simulation Center with its fully interactive 3-D simulation room. Laboratory space in the existing Science Building will be converted to classrooms, as well as a dedicated laboratory for the University's Forensic Science program.

Methodist University received its first \$1 million dollar gift during the *Seeds on Good Soil* campaign. In fact, during the campaign, Methodist received four \$1 million dollar gifts. These included the gift from the Nimocks family to name the Fitness Center, as well as a gift from the Thomas R. and Elizabeth E. McLean Foundation for the Science Building addition. Other significant gifts included \$750,000 from BB&T Foundation, the largest corporate gift in Methodist's history, and \$550,000 from the Kresge Foundation. Also significant was the fact that over 2,857 individuals, corporations, and foundations contributed to the campaign. Included in this number were 1,385 of Methodist's 9,961 alumni and former students.

The new buildings will be dedicated during the beginning of the fall 2007 semester. Plans are to have the primary Donor Recognition Wall honoring those who gave \$1,000 or more housed in the lobby of the Fitness Center, with a smaller recognition wall honoring those that gave specifically to the Science Building addition housed in the lobby of that building. 

GIFT OF LIFE INSURANCE

In November of 2006, the University received \$112,446 in life insurance proceeds from Mrs. Carol Dudley Nance, who passed away on Oct. 2, 2006.

The policy was actually taken out in 1992 by her husband, Mitchell Nance, with premium payments of \$38,614. Mitch and Carol Nance had supported Methodist financially, as well as with their time and talent, since the mid 1960s. Mitch, who passed away July 26, 2002, was a charter member of the University's Board of Visitors, and worked for a number of years as a volunteer during the annual Loyalty Day campaign.

As this gift was not designated for a particular purpose, Methodist placed the funds in an area of the endowment to ensure that funds will continue to be available to help meet the future needs of Methodist University and its students.

GIFT OF BEQUEST

Dr. Pauline Longest was a beloved science and math professor at Methodist from 1962 through 1979. Mrs. Longest spent 40 years of her life instilling in students a love of science. Following her retirement in 1979, Methodist honored her by developing and naming the Pauline Longest Nature Trail along a beautiful tract of Cape Fear River bluff land. Dr. Longest passed away on Nov. 1, 2005 at the age of 92. In 2006, the University received from her estate a gift of \$50,000, to be placed in the endowment, the earnings of which will be divided between the upkeep of the nature trail named in her honor, and purchasing equipment and supplies needed by the Science Department. By naming Methodist in her will, Mrs. Longest provided a way to continue the support of her life's work.

DR. LOUIS SPILMAN, JR. ENDOWED SCHOLARSHIP



He became a member of the University's Board of Trustees in 1970 and continues to serve today. Each year, alumni strengthen their alma mater by using their Greatest Gift Scholarship to help recruit deserving students. Every alum can award one new scholarship per year to a full-time day student that he or she actively recruits for undergraduate admission.

In 2006, a record 114 alumni assisted in recruiting new students to Methodist University. A total of 312 students received Greatest Gift Scholarships. As a result, \$183,100 was awarded in scholarship aid – all because alumni told prospective students about Methodist and were willing to fill out a one-page form! 


